#### DISTRICT OF INVERMERE

### **BYLAW NO. 1131**

A bylaw to provide for procedures to conduct local government elections and other voting.

**WHEREAS** under the *Local Government Act*, the Council may, by bylaw, determine various procedures and requirements to be applied in the conduct of local government elections and other voting;

**AND WHEREAS** the Council wishes to establish various procedures and requirements under that authority;

**NOW THEREFORE** that the Council of the District of Invermere, in open meeting assembled, enacts as follows:

#### Citation

1. This Bylaw may be cited as "Election Procedures Amendment Bylaw No. 1131, 2002".

# **Voting Day Registration Only**

- 2. (a) As authorized under section 55 of the *Local Government Act*, at each election or other voting, electors who wish to vote at such elections or other voting are required to register at the time of voting.
- (b) Registration as an elector under subsection (1) is effective only for the election or other voting for which the voting is being conducted at that time.

## **Advance Voting Opportunities**

- 3. (a) In addition to the required advance voting opportunity on the  $10^{th}$  day before general voting day, an additional advance voting opportunity shall be held on the  $2^{nd}$  day before general voting day.
- (b) The voting hours at the advance voting opportunity on the 10<sup>th</sup> day before general voting day will be from 8:00 a.m. to 8:00 p.m.
- (c) The voting hours at the additional advance voting opportunity on the 2<sup>nd</sup> day before general voting day will be from 8:30 a.m. to 4:30 p.m.
- (d) As authorized under section 98 of the *Local Government Act*, the Council authorizes the Chief Election Officer to designate the voting places for the additional advance voting opportunity.

Order of Names on Ballot
4. (a) The order of names of candidates on the ballot will be determined by lot in accordance with section 107 of the <i>Local Government Act</i> .
Resolution of Tie Votes after Judicial Recount
5. (a) In the event of a tie vote after a judicial recount, the tie vote will be resolved by conducting a lot in accordance with section 141 of the <i>Local Government Act</i> .
Repeal of Previous Bylaw
6. "Election Procedures Bylaw No. 739, 1993" is repealed.
